Internet Usage Policy

Rationale:

The use of technology is an integral part of our curriculum and provides children with the technological skills they will need to live in our modern World. At Teagues Bridge we use computing skills across all curriculum areas, this involves using internet to look at sources of information.

The internet provides pupils with unprecedented opportunities to obtain information, engage in discussion, and liaise with individuals, organisations and groups world-wide so as to increase skills, knowledge and abilities.

Our Ethos:

The school believes that the benefits to pupils accessing the resources of the Internet, far exceed the disadvantages. Ultimately, the responsibility for setting the standards that children are expected to follow, when using media and information resources, is one the school shares with parents and guardians. Whilst we embrace technology we are not in favour of children using socialnetwork sites such as Face book. We recognise that such sites are at the core of cyber-bullying and so we would strongly advise parents not to allow their children access and will inform parents and the local community support officers if we find these are being used in this way.

Aims:

0 To improve pupils learning outcomes by increasing access to information.

0 To develop skills in selective and effective usage.

0 To develop pupils awareness of safe management and usage of the internet.


0 To develop pupils awareness of the dangers on the internet.

Implementation:

- Teagues Bridge actively supports access by pupils to an appropriate variety of information resources accompanied by the development of the skills necessary to filer, analyse, interpret and evaluate information encountered.
- The LA ICT team ensure that children are not able to access anything inappropriate, certain information's and website will be blocked to primary age children and they cannot access these, a message will appear reading 'access denied'.
- An internet use agreement will be signed by pupils and parents, and will be kept by the teacher.
- All pupils will be responsible for notifying their teacher of an inappropriate material that others might be trying to access.
- All staff will be responsible for advising the headteacher of any inappropriate materials or words trying to be accessed by children.
- O Pupils who try to access inappropriate material or use inappropriate words, will have their access rights revoked.
- Signed parent consent is required in order for children to have their photo published on the school website.
- Only the pupil's first name will be sued on materials/photographs on the schools internet site.
- Privacy of pupils, parents, staff and other users must be recognised and respected at all times.
- Pupils will be made aware of the potential consequences of cyber bullying and will be dealt with by the school on individual case basis.
- Pupils must always seek permission from their teacher to download or copy any files or documents.
- Pupils should never give out personal information such as surname, address, telephone number, and parents work address/telephone number.

Evaluation:

This policy will be reviewed every two years in consultation with TEAM SAS Crew (children's safeguarding group).







Pupil Acceptable Use Policy Agreement

I understand that I must use school ICT systems in a responsible way, to ensure that there is no risk to my safety and security of the ICT systems and other users.

For my own personal safety:

- O I understand that the school will monitor my use of the ICT systems, e-mails and other digital devices.
- I will treat my username and password like my toothbrush ~ I will not share it, nor will I try to use any other person's username or password.
- 0 I will be aware of 'Stranger Danger', when I am communicating on-line.
- 0 I will not disclose personal information about myself or others when on-line.
- I will immediately report any unpleasant or inappropriate material or message or anything that makes me feel uncomfortable when I see it on-line.
- 0 I will not enter chat rooms/blog sites without adult permission.

I understand that everyone has equal rights to use technology as a resource and:

- I understand that the school ICT systems are primarily intended for educational use and that I will not use the systems for personal or recreational use unless I have permission to do so.
- O I will not try to make large downloads or uploads that might take up internet capacity and prevent other users from being able to carry out their work.
- I will not use the school ICT system for on-line gaming or video broadcasting (you Tube), unless I have permission from a teacher.
- 0 I will not print work from the internet unless I have permission from a teacher.

I will act as I expect others to act towards me:



- O I will respect others' work and property and will not access, copy, remove or alter any other files, without the owner's knowledge or permission.
- I will be polite and responsible when I communicate with others, I will never use inappropriate language and I appreciate that others may have different opinions.
- 0 I will not take or distribute images of anyone without their permission.

I recognise that the school has a responsibility to maintain security and integrity of technology it offers me and to ensure the smooth running of the school:

- I will only use personal hand held devices in school if I have permission. I understand that, if I do use my own device in school, I will follow the rules set out in this agreement.
- O I understand the risks and will not upload, download or access any materials which are illegal or inappropriate or may cause harm or distress to others, nor will I try to use any programmes or software that might allow me to bypass the filter/security systems in place.
- 0 I will immediately report any damages or faults involving equipment or software, however this may have happened.
- 0 I will not open attachments to e-mails unless I know and trust the person who sent the e-mail.
- 0 I will not install or attempt to install programmes or alter computer settings.
- 0 I will only use social network sites with permission from the teacher/Parent.




When using the internet for research, I recognise that:

I understand that I am responsible for my actions, both in and out of school:

- O I understand that the school also has the right to take action against me if I am involved in incidents that are not acceptable and are outlined in this agreement. This includes when I am outside of school e.g. cyber bullying, use of images or sharing personal information).
- I understand that if I fail to comply with the Acceptable Use Policy Agreement,
 I will be subject to specific actions set out by the headteacher. This may
 include loss of access to the school network, behaviour plan, parents will be
 contacted and in the event of illegal activities, police will be involved.
