

Reasons for a no debt policy?

As from September 2013, Teagues Bridge Primary School has adopted a clear 'No debt' policy relating to the school meal service. If debts are incurred, then the school budget has to pay for them. This means that money which should be spent on the children's education is used to pay for debts incurred by parents. Every parent will agree that this is unacceptable, and we request that all parents give this policy their full support.

Parent/s/Carer's must pay in advance for the school meal by using Parentpay — cashless system online (further details can be obtained from the office). Children will not be provided with a school meal unless it is paid for, except those entitled to free school meals. If a parent genuinely forgets to pay in advance, the school may grant a debt allowance of I meal. However, this debt must be paid the next day and future meals must be paid in advance before any meal is provided.

If the debt is not cleared, parents must either provide a packed lunch or take the child home for lunch.

School Meals Pay Policy

If payment of the debt is not received by the next day, the head teacher reserves the right to begin legal proceedings against the parent to recover the debt. Social services may also be informed that these parents are not carrying out the responsibility of care by not providing food for their children at lunch time.

We hope that by implementing this policy we are able to help parents manage school dinner money better and at the same time ensure all money that is for children's learning is available.

Aims of the document

- To outline the school policy regarding school dinners;
- To ensure the smooth, efficient and cost-effective operation of the school dinners.
- To present the operational procedure for obtaining school lunches.
- To clarify the roles and responsibilities of staff, parents and children.

School meals are available to children at a cost of £2.45 per day (£2.50 from September 2023)

There is no cost for those children in receipt of free school meal entitlement. The payment of school lunch is required in advance on a weekly, half termly or termly basis.

To enable the school dinner service to be efficiently planned the School requires advance notice of your child's requirements.

School Meals Payment

School meals should be paid for in advance, via Parentpay — online payment system, either for the week, half-term or term. In the event of insufficient funds being available the parent/carer should contact the school immediately and arrange to bring a packed lunch no later than II.30am. If a child arrives at school without a lunch, the parents will be telephoned and asked to make alternative arrangements. Debts of any amount will not be tolerated.

If the parent is unable to be contacted or refuses to provide a packed lunch, then a child protection referral may be made on the grounds of neglect.

A reminder letter message be sent when funds in the online payment account are at £10.00 or less.

A message will also be sent if your account becomes in debt by I meal, £2.45. This must then be paid immediately.

In cases of genuine financial hardship, the school can make arrangement for a short term staged payment plan (however this should never be necessary as accounts should not exceed a debt of £2.45.

Free School Meals

It is the parent/carer's responsibility to complete the necessary documentation required for free school meals. This prevents parents/carer's falling into unnecessary arrears.
